- Coordinate the registration and accreditation process with regulatory bodies.

- Follow up with the relevant departments to ensure that there are demonstrable processes and ongoing efforts to improve the quality of services.
- Drive the Quality Management initiatives

towards the maintenance of the ISO certification.

- Support ongoing research and review of the QA/QM framework used for internal quality controls and assurance.
- Liaise with HRDC/BQA for the registration and accreditation process.
- Communicate registration and accreditation decisions to Management and coordinate with them for implementation of the regulatory body recommendations
- Coordinate the conduct of quality inspections/ visits by regulatory bodies to monitor and ensure compliance with legislative and regulatory requirements.

### **QUALIFICATIONS:**

 At least a Degree in Educational Management, Quality Assurance and a professional quality certification (ISO, etc.) or any other equivalent qualification acceptable to IDM.
