

HE CONTROVERSY OVER pending Botswana Democratic Party (BDP)'s primary elections, commonly known as Bulela Ditswe, is far from over as a new method to select Parliamentary candidates in some constituencies is under discussion with suggestions to subject some contestants to oral interviews to trim the numbers, The Patriot on Sunday has learnt.

This is after scores of BDP members who had been vetted to contest for Bulela Ditswe ignored the call made by BDP Chairman Slumber Tsogwane recently for them voluntarily withdraw from contesting and that they will be refunded their application fees. BDP sought to reduce the numbers through that

Information reaching this publication is that the party president Dr Mokgweetsi Masisi and his central committee are toying with the idea of approaching BDP structures on how to best select the candidates.

According to the impeccable sources, the plan that is being discussed behind the scenes is that the BDP's Political Education and Elections Committee (PEEC) select the candidates by interviewing some of them.

However, it is said the proposal has caused divisions between NEC and the PEEC, with the PEEC being reluctant to thumb up such plans with fears being that it could result in backlash from the members.

It is said Masisi, and the central committee are under huge pressure as BDP primaries remain a pie in the sky, amidst democrats losing

patience implying that delay signals that BDP isn't ready for 2024 elections.

Kario

Contacted for a comment about suggestions/ plans to interview some Bulela Ditswe candidates, BDP Secretary General (SG) Kavis Kario was cagey with details, but said the BDP is not intending to adopt any method other than the method of candidate selection (elections) as dictated by BDP Constitution, Rules and Regulations.

At the beginning of the year, the BDP central committee attempted but in vain to lobby the party branch committees and regions to opt for consensus candidates in different constituencies where possible with the intention of consensus candidates being based on speeding up the process of candidates' selection.

Traditionally, BDP conducts its primary elections a year before general elections and normally

starts with constituencies that are under the incumbency of opposition and proceed to those under its incumbency.

However, to date with just less than four months behind elections scheduled for October, BDP hasn't began the process of fielding candidates, a move which observers suggest it shows BDP is under siege.

Meanwhile, Kario also said the party has received requests for withdrawal by some candidates from contesting Bulela Ditswe as per the memo issued by Tsogwane, adding the requests will be processed and actual numbers of those candidates who withdrew will be determined by the end of this week.

Grand Plan

He also bashed claims and criticism raised by some within and outside the party that the BDP is not ready for elections given the delays in conducting Bulela Ditswe with that leading to a slow start for campaigns as well as the release of the 2024 elections manifesto, but Kario is adamant BDP is ready.

"We are very ready for elections on terms of our preparedness to be assessed by voters on the delivery of our electoral promises. We have done a great job in this regard," said Kario confident of BDP victory.

Furthermore, Kario said all process related to elections at BDP level will be done in one and half months and that include primary elections, manifesto launch and issuance of campaign to both candidates and the campaign teams across the country. BDP is yet to identify candidates for the Maun East constituency.

Masisi recently hinted that BDP primary elections could be held either at the end of this month or the first week of July but as things stand, some democrats are doubtful on dates that Masisi have outlined that elections will be held more so that some of constituencies are behind in finalising the voters rolls.

He also emphasizes to those who will lose primary elections that there will be no time for the party to listen to their appeals and therefore whoever suffer defeat must prepare to rally behind the winners.

HE ALLIANCE FOR Progressives (AP) has broken ranks with the Umbrella for Democratic Change (UDC) coalition and instructed its candidates not to participate in a series of manifesto workshops for candidates.

The first UDC manifesto workshop was scheduled for Palapye yesterday (Saturday). It is said the AP's boycott of UDC elections preparations emanate from a number of disapprovals that had been raised and put forward before UDC central committee but were not addressed as AP had expected.

AP Secretary General (SG) Dr Phenyo Butale on Friday issued a statement to AP regional chairpersons and secretaries, the branch chairpersons and secretaries and parliamentary and council candidates informing them of the party's decision not to participate in the UDC manifesto candidates' workshops. Dr Butale said the party has received a number of complaints from many council candidates about recent developments regarding ward allocations. UDC partners are still at loggerheads over wards. "Taking into consideration the fact that ward allocations have not been concluded, the AP Central Committee has decided that the party's candidates will not participate in the trainings pending the conclusion of all outstanding ward allocation issues," Dr Butale said in letter to the AP structures.

In addition, Dr Butale said the AP candidates are therefore informed not to attend the workshop in Palapye, a development which observers say shows that UDC internal wranglings are intensifying.

Contacted further for a comment, Dr Butale confirmed the AP decision but said the memo issued was internal and not for public consumption including the media hence its leaking was very

unfortunate, adding that AP has informed UDC over its decision of AP candidates not partaking in the workshop.

UDC Head of Communications, Moeti Mohwasa did not respond to enquiries sent to him.

Meanwhile, a UDC statement dated 20th June noted that over the weekend UDC will hold two-day workshop for its candidates in constituencies North of Dibete and will be followed by another in Jwaneng on the 29th and 30th June for parliamentary candidates in the South of Dibete.

BNF Radicals

Some of the paramount complaints that have been raised by AP is the continuous disregarding of UDC constituencies allocation decisions by some of Botswana National Front (BNF) members who have also since launched parallel campaigns in constituencies and wards that had been allocated to AP by UDC.

BNF member and former Molepolole South MP Dr Tlamelo Mmatli has been campaigning together with Shima Monageng of AP while at Mmopane-Metsimotlhabe BNF cadre Gilbert Watshiphi squared off against AP's Pushie Manyaneng.

The argument by both Dr Mmatli and Watshiphi are that both Molepolole South and Mmopane-Metsimotlhabe are BNF strongholds hence AP is not deserving to contest for them.

Dr Mmatli and Watshiphi were UDC parliamentary candidates during the 2019 general elections.

Dr Butale said the issue of Molepolole South and Mmopane-Metsimotlhabe has been attended to and those who were campaigning unlawfully have been informed to stop because the constituencies have been allocated to AP.

"We are committed to the UDC project as AP hence our call for pending issues to be concluded expeditiously," said Butale in an interview on Friday

Game Changer or a Curse!

- 30% of P2 million funding for women candidates
- BCWP hopeful funding can boost women participation
- Women representation remains low across parties

OTSWANA WOMEN CAUCUS in Politics (BWCP) has expressed concern over the low numbers of women contesting Parliamentary seats in the 2024 general elections and is hopeful that political party funding will change the fortune of female candidates to win more seats.

In an interview on Thursday, the acting president of BWCP, Rhoda Sekgororoane said if approved, the political party funding bill will attract more women candidates. She said one of the findings of a research conducted by Emang Basadi titled Mme Okae revealed that women are not contesting political office because of lack of funds, because the exercise is currently expensive.

Sekgororoane said BCWP has for many years been preparing women candidates for elections by bringing them together and training them on how to best sell themselves to the electorates. "The following are the numbers of some women candidates who are standing for Parliament:

BDP 20 women BCP 6, BNF 1, BMD 0, BPF 0. And mind you, some of these women are still to go through primaries which might not favor them. So, it's still difficult for women to ascend to these positions of power and the Caucus intends to lobby President Mokgweetsi Masisi to allocate the newly increased specially elected MPs seats to women," she

She explains that BWCP objectives are to provide a forum to exchange ideas and chart a way forward for the political empowerment of women in Botswana and to forge strategic alliance with internal and external organizations and individuals.

Parties

Meanwhile, Botswana Congress Party (BCP) Publicity Secretary, Dr Mpho Pheko said out of 54 Parliamentary candidates, only six of them are women. She said the constituencies that women are contesting are Gaborone Central, Mochudi West, Boteti East, Mogoditshane West, Lobatse and Mahalapye East.

"Our women numbers situation is worrisome, but women are deterred issues like Cultural barriers, cost of family care which culture imposes on women, all these impacting women's confidence," said Dr Pheko.

In addition, she said the bigger challenge is the First- Past -The -Post (FPTP) electoral system, adding that the system is rigged against women and youth as the system is designed for men with money. "Look at all countries that are having more than 30% rep in parliament they use Mixed promotional representation or promotional representation. Rwanda, Ethiopia, Namibia, South Africa. Rwanda has a constitutional mandate of minimum 30% women," she said.

For her part, Botswana National Front Women's League president (BNFWL). Katlego Morolong said they set aside 30% quota for women contesting elections but said the resolutions were that consideration will be given for women candidates who won 2019 elections, those who won by-elections and consensus candidates.

Morolong said they are still to compile information and see how many women who will be contesting for general elections and that will be finalized once primary elections are

concluded in all constituencies. Funding formula The Minister of State President,

Kabo Morwaeng is expected to table the political party funding bill before the upcoming July Parliament session where political parties will share views on budgeted P34 million.

A government white paper proposes funding formula of 20% of P2 million for a seat won by a male candidate and 30% of P2 million for a seat won by a female candidate, with P2 million being the maximum election expense amount specified

under Section 81 of the Electoral Act. Delivering the 2024/25 budget in February, the Minister of Finance, Peggy Serame announced that government will set aside P34

million to finance political parties to improve Botswana's democratic credentials by levelling the campaign field. The government political party funding dispensation comes after submissions in support of public funding of political parties were raised to the presidential commission on constitutional review that was led by former Chief Justice Maruping Dibotelo.

Submitting its final report, the commission then recommended that "Political party funding be introduced based on parliamentary seats won by parties in the immediate past general election at the rate of not less than P50,000 or such amount as may be determined by Parliament from time to time per Member of Parliament." The commission also

recommended that political parties, which received public funding should account for the use of such funds to the Office of the Auditor General following general elections. During 2019 general elections, the

ruling Botswana Democratic Party (BDP) won ma 38 parliamentary seats, UDC coalition comprising BCP, Botswana National Front (BNF) and Botswana Peoples Party (BPP) respectively garnered 15 seats. On the other hand, Botswana

Patriotic Front (BPF) won three (3) seats and Alliance for Progressives (AP) one (1).

MLGRD pays P3m to save assets

- Settles subcontractors and Deputy Sheriff fees pending appeal
- AG fights P40 million award to Lamworld Technologies

FTER ALMOST TWO MONTHS OF battling for the return of government property worth over P40 million seized by deputy sheriffs, the Ministry of Local Government and Rural Development (MLGRD) has finally managed to strike a temporary deal.

This deal involves a settlement payment of over P3 million, pending the appeal of the matter. Under the terms of the agreement, the Ministry will immediately pay P3,147,316.40 to Lamworld Technologies, covering retention fees and interest due for a works contract involving the construction of water treatment plants and evaporation points at New Xade and Radisele.

A portion of the settlement will also be allocated to the deputy sheriff. Upon receipt of the payment, the deputy sheriff will restore the attached movable property to the Ministry's premises. Additionally, Lamworld and the sheriff have undertaken not to attach or remove any further property from the Ministry pending the appeal hearing brought by the Ministry.

A savingram from the Permanent Secretary of the Ministry sent to the Attorney General, seen by The Patriot on Sunday shows that the ministry was initially worried on whether striking a deal with Lamworld Technologies will not compromise their chances of success in the appeal which they have launched, a concern the Attorney General answered saying "settlement will not in any way prejudice the Ministry's right with respect to the appeal".

The Ministry's legal troubles began in April when the High Court granted a writ of execution against them for failing to fulfill payment obligations to Lamworld Technologies. The court order followed a prolonged dispute over contractual issues between the Ministry and Lamworld, which was contracted to construct water treatment plants and evaporation ponds in New Xade and Radisele.

Despite the High Court's ruling in September 2022, ordering the Ministry to settle its dues to Lamworld Technologies, the Ministry failed to comply, prompting Lamworld to seek further legal recourse. After successfully applying for a writ of execution to recover the outstanding sum of P39,873,718.03, Lamworld wasted no time enforcing the court order.

During the enforcement of the order, the Ministry officials initially resisted but eventually relented and vacated their offices to allow the execution of the court order. The seized assets included vehicles, computers, office furniture, and other properties owned by the ministry.

PS seeks freedom

The temporary settlement deal sets free the Permanent Secretary (PS) in the Ministry of Local Government and Rural Development, Gabatlotlane Mogapi, who is facing a contempt of court order that almost committed her to 30 days in jail.

In Mogapi's court papers' plea for liberty, she said after Lamworld cited her in their counter application against AG and sought for her arrest for contempt of court, arguing that: "It is beyond any doubt that I have a substantial interest in any matter in which my constitutional right to liberty is being threatened and any party seeks to interfere with it."

Mogapi explained that she was applying to be joined in the counter application as a party to enable her to defend her constitutional right to her liberty. She pointed out that it was incumbent on Lamworld, who sought reliefs affecting her personal liberty, to have joined her to the proceedings before it sought and obtained an order potentially taking away her liberty.

"I therefore, humbly pray that I be joined as a necessary, affected and material party to the counter application launched by the company," the PS said. Mogapi said she was seeking that should she be successful in the joinder application; she wishes to move for the rescission of the court order granted to Lamworld on March 25, 2024 on the basis that an order prejudicially affecting her liberty has been sought and obtained by the company without citing her as a party.

"The company sought and obtained an order for my personal attachment without notice to me. They also did not serve its counter application for my committal to prison for contempt of court without having served me with a copy of the application personally," she said.

Botswana hosts media, pre-elections summit

otswana will on Monday and Tuesday (24th -25th June 2024) host a summit on strengthening freedom of expression and access to information to enhance electoral integrity.

The two-day event is organised by Campaign for Free Expression (CFE) which has partnered with United Nations Botswana, Botswana Editors Forum (BEF), Frederick Ebert Stiftung (FES), Botswana Council of Non-Governmental Organizations (BOCONGO), and the University of Botswana, to host this Freedom of Expression Summit in preparation for Botswana's 2024 general elections. The summit is anticipated to attract freedom of expression enthusiasts, policymakers, academia and civil society in unpacking the freedom of expression debate pre and post the 2024 elections. The summit will offer an opportunity for collaboration, knowledge exchange meant to ensure transparent elections in Botswana.

During the summit, panelists will zoom into a plethora of pressing media topics

such as an overview of the current state of freedom of expression in Botswana, legal frameworks and regulations governing or impacting freedom of expression and access to information during elections, freedom of expression in the context of elections, and regulatory frameworks enabling free and fair coverage of elections to mention but a

According to Botswana Editors Forum Secretary General, Keikantse Shumba, the role of the media in a democracy is primarily to inform, educate and of course to hold power to account. She said the media should inform so that citizens make informed decisions as opposed to making decisions out of ignorance, misinformation, disinformation, or even propaganda.

"During an election, an independent media must, over and above just providing coverage to political parties, set the agenda to discuss issues such as freedom of expression and how it affects the electoral process, which is exactly what this summit has set out to do by bringing together



stakeholders under one roof to talk about; strengthening freedom of expression and access to information in order to enhance electoral integrity," she said.

In 2023, Reporters Without Borders Press Freedom Index ranked Botswana 65/180. The indicators are; legislative framework, economic, socio cultural and political. Despite that, pundits still argued that more had to be done especially from a legal perspective. However, in 2024, Botswana dropped 14 places to the rank of 79/180.

"The law on access to information has yet to see the light of day," stated the report. It added: "The 2008 Media Practitioners Act was repealed in 2022 and replaced by the Media Practitioners' Association Act, in order to better protect the media's freedom and independence. But it contains a provision making it obligatory for a journalist or media to be affiliated with a local organisation, which is seen as discriminatory."

Amidst weak legislative frameworks regarding freedom of expression, President

Mokgweetsi Masisi has on the occasion of this year's World Press Freedom Day promised that the bill will be tabled in the winter session of Parliament. Botswana has been called to devise laws that enable for the free role of media which has been pivotal to the sustenance of democracy since attainment of independence. In the past, security organs like the Directorate of Intelligence and Security Services (DIS) have proved to be a stumbling block to the operations of the media and other freedom of expression activists. The DIS has been accused of harassing, intimidating and arresting journalists. Journalists also face online threats through doxxing (an act where their private/personal information is published on the internet for malicious intent). This is done by politicians, and their followers in some instances.

Consequently, the summit will seek to bring such issues to the fore and how they can be countered during and beyond elections.

AI Pest Detection tool wins Prize for Engineering Innovation

sther Kimani was named winner of Africa's biggest engineering prize, the Royal Academy of Engineering's Africa Prize for Engineering Innovation, in Nairobi on 13 June 2024. Her early crop pest and disease detection device was selected as the winning innovation for its ability to swiftly detect and identify agricultural pests and diseases, reducing crop losses for smallholder farmers by up to 30% while increasing yields by as much

Five million smallholder farmers in Kenya lose on average 33% of their crops to pests and diseases. Kimani's innovation not only provides real-time alerts within five seconds of an infestation, offering tailored intervention suggestions, but also alerts government agricultural officers to the presence of diseases or pests, contributing to broader agricultural management efforts.

The solar-powered tool uses computer vision algorithms and advanced machine learning to detect and identify crop pests, pathogens or diseases, as well as the nature of the infection or infestation. The device then notifies the farmer via SMS. This affordable alternative to traditional detection methods leases for just \$3 per month, significantly cheaper than hiring drones or agricultural inspectors.

The annual Africa Prize was founded by the Royal Academy of Engineering in 2014 to support innovators developing sustainable and scalable engineering solutions to local challenges in Africa. This year has seen the Africa Prize alumni community grow to almost 150 entrepreneurs from 23 countries, who together have generated more than 28,000 jobs and benefitted more than 10 million people through their innovative products and services.

To celebrate the 10th anniversary of the Prize, the Royal Academy of Engineering hosted the Africa Prize Alumni Reunion, bringing together 100 innovators

from the past decade for a three-day programme ahead of the final ceremony. This momentous occasion showcased the strength of the community united by the

Esther said: "My parents would lose up to 40% of their crops each farming season, which affected our standard of living. We are empowering smallholder farmers, many of whom are women, to increase their income. We aim to scale to one million farmers in the next five years."

Malcolm Brinded said: "These awards form part of the Royal Academy of Engineering's investment of over £1 million to African innovators through grants, prizes and accelerator programmes during the

tenth anniversary year of the Africa Prize." Esther received KSh 8.3 million to further develop the device. This is the largest amount awarded to a winner, in honour of

the 10th Anniversary of the Prize. The four finalists delivered their final business pitch to the Academy judges and an in-person audience of approximately 700.

The three runners up that were each awarded KSh 2.5 million to develop their innovations, were:

Eco Tiles, Kevin Maina, Kenya: An environmentally friendly roofing material made from recycled plastic. Stronger and lighter than clay or concrete tiles, the innovation is a dual solution to plastic pollution and high building costs.

The innovative manufacturing process involves a custom-made extrusion machine that blends different plastics at varying temperatures, eliminating the need for energy-intensive processes like kiln-burning and reducing carbon emissions. The tiles are enhanced with UV stabilisation chemicals and construction sand to improve durability and sturdiness.

La Ruche Health, Rory Assandey, Côte d'Ivoire:

La Ruche Health connects communities to vital health information, advice, and services through "Kiko", an AI chatbot tool available on WhatsApp and mobile apps, and a digital backend solution to streamline documentation, billing, and data sharing for

By May 2024, the AI has facilitated over 150,000 user interactions and 189 in-home and teleconsultation appointments, processing over \$18,000 in medical billings, illustrating its effectiveness and scalability.

Yo-Waste, Martin Tumusiime, Uganda: Addressing Uganda's mounting waste crisis, Yo-Waste is a location-based

mobile application that connects homes and businesses to independent agents for efficient on-demand rubbish collection and disposal.

Yo-Waste currently serves over 1,500 customers including homes, businesses, and waste collection agents, with a goal to reach 20,000 users by 2026.

A separate 'One to Watch' award was also awarded to Dr Abubakari Zarouk Imoro for his innovation, Myco-Substitutes, on the night for their innovation's impact on local communities. Voted for by live and online audiences, Dr Imoro receives £5,000, conferred in 2024 in honour of Martin Bruce, a late Ghanaian alumnus of the Africa Prize.

The 2025 Africa Prize for Engineering Innovation, launched at the 2024 final, is now open for entries. The Academy is looking for scalable engineering solutions designed to solve local challenges, and individuals and small teams living and working in sub-Saharan Africa are invited to enter. The importance of the media during elections: Botswana case

S THE DATE OF Botswana general election is awaited with bated breath by everyone with keen interest in elections, Botswana will be hosting Freedom of Expression Summit from 24th to 25th June 2024. The theme of the summit is 'Strengthening Freedom of Expression and Access to Information to Enhance Electoral Integrity.'

I found the theme too attractive, relevant and compelling to be ignored particularly in the Botswana context. This because while Botswana has an entrenched provision in the Bill of Rights with respect to Freedom of Expression, she lacks dismally with respect to Access to Information legislation. The media fraternity and other key stakeholders like the civil society organisations have for the longest time decried the importance and desirability of Freedom of Information Act but to no avail. Government has for the longest time acted in bad faith by acknowledging the desirability of the Act, yet playing hide and seek to facilitate the passing of such an Act in Parliament.

Strengthening Freedom of Expression While the Freedom of

Expression is guaranteed by the Constitution under the Bill of Rights, this right has been under constant and consistent threat from the Directorate of Intelligence Service (DIS) in so far as members of the media are concerned. I must point out that to the best of my recollection, no member of state media has ever been so unjustly harassed by intelligence agents as do members of the private media.

Not very long ago, the Editor of Mmegi newspaper and a Senior Reporter were rounded up by DIS on the eve of their newspaper going for print. The arresting party told the newspaper journalists that DIS members are the law themselves, suggesting that they are above the law. Before this incident, other members of the private media have been harassed, arrested, and detained by DIS with their tools of the trade unjustifiably confiscated. Freedom of Expression cannot be enjoyed by members of the media and other citizens when they have to constantly look over their shoulders whether DIS is lurking in the horizon. In particular, it inhibits journalists in large measure to report on election matters with absolute freedom and peace of mind.

Access to Information crucial Only primitive democracies

short of dictatorship will always find it hard to play its cards out. Freedom of Information is crucial in holding government accountable to enhance good governance and transparency amongst others. The importance of electoral integrity in any progressive democracy which I suspect will be one of the topical issues under the Summit theme, cannot be overemphasised for obvious reasons. That said however, it is critical to mention that for any election to pass the test, its integrity must not be in doubt under any circumstances. It is a virtue all progressive democracies must strive to achieve. The doubt about electoral integrity in Botswana is caused by the fact that the Independent Electoral Commission (IEC) is a government department under a Minister in the Office of the

or lack thereof. Just before the 2019 general election, the DIS was alleged to have infiltrated the IEC database by buying ID verification equipment under the claim that such database was vulnerable to election rigging. By any account, this was a huge story particularly in an election year. It will be remembered that the results of this election were heavily contested in court although the case was dismissed on technicalities. It is a given that the media would have wanted, in the public interest, to dig deep into these allegations in order to find the truth. As I write, there are so

many controversies around the voters roll wherein for example, opposition political parties are demanding soft copies of the voters roll as such has been the case before. The IEC has adopted a casual response to these demands to the point where it could be said it is asking these parties to jump into the nearest dam. Given this state of affairs, electoral integrity becomes extremely under threat because doubts linger in people's minds. Access to Information Act would have enabled the media to protect such integrity in some form or the other. Government is not

prepared to be held accountable by making it easy for the media to access un-harmful information for the sake of the

Abuse of state media Back in the day, Botswana was described as a beacon of democracy with ambitious calls that other countries should benchmark with her. That was the era when words like vote rigging were hard to come by. If indeed this Republic was ever a beacon of democracy, that era is dead and buried. And the death of progressive democracy in this country must be blamed on the ruling Botswana Democratic

Party (BDP) because it is the only political party that has governed since 30 September 1996. The obligation was and still is with the party by virtue of being at the helm of governing Botswana for over five decades.

The fact that the media is a key stakeholder in politics on one hand and elections on the other cannot be overemphasised. In recognition of the fact that State media particularly the television platform is accessible in the remotest parts of Botswana, the BDP has over the years almost shut out opposition political parties from this platform such that they are not exposed to many Batswana. In 2016/17, the Ombudsman ruled that it is unfair for the BDP to enjoy about 80% of Botswana television coverage while opposition political parties share between them the remaining, paltry 20%.

Yet, State media is funded through public funds and not BDP's. With 80% television coverage, not all BDP politicians are not so lucky to be covered except for the President, his deputy and the Minister in the President's office. The complaint against unfair television coverage was lodged by an opposition political party member. Just two weeks ago,

the BDP and Botswana Patriotic Party (BPF) held two rallies at different venues during the same weekend. The distance between the venues is a mere 40 kilometres. BDP rallies were widely covered while there was blackout on the latter's.

The long and short of my humble contribution is that while the Freedom of Expression is provided for in the Bill of Rights under the Constitution, it is nevertheless under serious threat from the intelligence agency. It is taken away particularly from private media practitioners as and when the agency so desires. It is fair to suggest such can only be the case under primitive if not backwards democracies. Equally so, lack of Freedom to Information Act does not help the private media cause. And so is the monopoly of State media by the BDP at the detriment of opposition political parties. The sum total of these compromise electoral integrity in no small measure. As we approach the 2024 general election, the IEC is in the spotlight owing to its questionable shenanigans. Have a productive and fulfilling summit. I am prepared to be persuaded otherwise as always. Judge for Yourself!

OTSWANA, HOME TO the largest elephant population in the world, faces inevitable conflict between humans and elephants. administration was uplifted in 2019 by President Mokgweetsi Masisi government to resolve this human-elephant conflict. The main beneficiaries of the trophy ban uplift are supposed to be the Batswana communities who often find themselves in direct conflict with elephants. This is not the case as evidenced by previous articles including The Journal of African Elephants on the matter. Instead, middlemen are benefiting at the expense of communities who are supposed to be the main beneficiaries of the trophy hunting ban lift, which is why the new government policy is geared toward managing this challenge. According to the Minister

of Environment and Wildlife Dumezweni Mthimkhulu, the policy of trophy hunting is a way of controlling the elephant population akin. The policy seeks to also empower local communities in direct conflict with elephants in the North West region. Since coming into policy, the trophy hunt ban has only benefited middlemen connecting trophy hunters with local communities. Trophy hunters come into the country having already arranged for their hunt through European middlemen who facilitate the hunt and the profits never get realized by local communities.

The so-called middlemen connect local communities with trophy hunters who are in the country to hunt wildlife and in the process get an adrenalin shot. Trophy hunters pay money to European middlemen who go on to keep most of the trophy hunting money. Middlemen pay a paltry fee to local communities so that a trophy hunt takes place on the local's land without much gain. Middlemen also contribute to capital flight, an issue that the African union has called out in their latest report about money moving out of Africa unaccounted for.



Trophy hunting

To address this challenge, the Botswana government introduced the Community-Based Natural Resources Management (CBNRM) policy as an attempt to address the issue of capital flight and communal empowerment in the trophy hunting industry. According to the CBNRM policy document and the USAID review of the CBNRM, the goal of the trophy hunting policy is communal sustainable development. The CBNRM aims to equip communities with the skills to conduct independent sales without middlemen. The communal empowerment policy is the approach that the government seeks to achieve and manage, offering a different strategy for local communities to maximize their benefits from trophy hunting.

The alternative approach that government is introducing is the establishment of a regulatory board overseeing trophy hunting and the value chain to the benefit of local communities. This board seeks to issue licenses, monitor compliance, collect revenue,

and ensure that funds are directly distributed to affected communities, bypassing middlemen who contribute to capital flight. This bodywill also develop and implement policies to further the hunting industry as part of socio-economic growth. As opposed to local communities, a regulatory body is better placed to undertake market research and industry analysis. The human-elephant conflict is no longer a domestic issue confined to the boarders of Botswana. The matter is now also of interest to the international community as seen by British politicians deliberating whether to allow the importation of trophy hunting products. A regulatory body is better suited to address these international dimensions, a task beyond the capabilities of local communities. The idea of a regulatory body overseeing trophy hunting activity is not a new one. In South Africa there is the Professional Hunters Association of South Africa whose objective is the regulation of the trophy hunting industry.

A regulatory body can also

adopt a scientific approach to determine sustainable hunting quotas, balancing habitat preservation and animal population control to reduce human-elephant conflicts. Data from trophy hunting indicates that proceeds can significantly uplift local communities and contribute to the local economy if managed effectively.

It is imperative for energy landscape. government to take a proactive role in regulating trophy hunting to prevent further human-elephant conflict. Industry regulation is nothing new. The Gambling Authority of Botswana regulates gambling activities. The trophy hunting industry should be regulated. Through a regulatory body, the government can promote socioeconomic progress, manage the elephant population, and better conserve habitats. A regulatory body is best positioned to replace the role of middlemen, ensuring that the benefits of

This will help in impacting and inculcating an organisational culture of having strong principles and values on leadership, to provide a true and credible alternative to BDP type of government. The Commission will be responsible for preventing , detecting , investigating issues of integrity on leadership.

B.BNF PRIMARY ELECTIONS

1. The BNF as an organisation has been institutionalised and therefore has a constitution which lays and outlines governance framework. There are policies, and in the context of the matter at hand, there is BNF Electoral Rules prescribing democratic, transparent and fair process of conduct of primary elections and elections of structures. On that note we are

running a professional party based on established effective processes , procedures and organisational

2. The rules and decision making is bottom up not top down like in other parties.

3. The institutional structures are clear and independent from Central Committee.

4. The President was never involved and can never be involved, no member of Central Committee was ever involved.

6. If the event there are genuine complaints they are raised with National Elections Board 7.As i have already enunciated

, BNF has "Electoral rules", a document crafted by Central Committee and ratified by conference which is an instrument used for conducting primary elections and elections for organisational structures. Codifying these rules was meant to ensure fairness, professionalism, policy certainty and predictability, and most importantly good governance. The primary elections for wards and constituencies are run independently by Constituency Elections Committees in consultation with National Elections Board. In the event someone is aggrieved with the conduct in the process, there

is room for appeal to the National Elections Appeals Committee, which runs independently to ensure fairness and justice.

8.The Low numbers in some constituencies is a combination of factors- lack of resources to mobilise and bring people to the polling stations as we are an opposition party without resources, people finance democracy from their pockets, new data base constraints, deadline that was set for eligibility to vote in primary elections . So far we are the only party that have held so many primary elections, even BDP as the ruling party is struggling to have primary elections in a single ward, but political commentators are quiet

HE CENTRAL BANK, BANK OF Botswana (BoB), has in 2023 distributed P860.5 million to the Government of Botswana (GoB) with the distribution comprising P829 million pre-set dividend and

P31.5 million as the residual income. The bank's Chief Financial Officer (CFO) Daniel Loeto revealed this on Tuesday during the bank's economic briefing that included the launch of 2023 statutory annual report.

The 2023 distribution was higher than the P425 million which was paid out to Government in 2022 comprising of a dividend of P202 million and a residual net income of P222 million.

Loeto said the Government is the solo shareholder of the central bank and whatever profits that are made by BoB are declared to the government.

He also said the bank administration costs increased from P786.6 million in 2022 to P901.6 million driven mainly by the increase of P17 million in the fund

management fees, adding that when market performed well and therefore the bank had to pay the fees based on market values and in US Dollars.

Loeto said there was P2.4 billion net currency gains in 2023 compared to P1.9 billion in 2022

P8 BILLION INCOME Furthermore, the bank has

revealed in its 2023 statutory annual report that it has recorded a total comprehensive income of P8 billion as at December 2023.

Governor Cornelius Dekop said this outcome resulted from a combination of earnings on the foreign exchange reserves, unrealised fair-value (market) and currency

Dekop said the market gains were due to strong recovery in global bond and equity markets in 2023 in response to expectations of monetary policy easing as inflation rate declined. Against this background, he noted that the value of the foreign exchange reserves increased by 16.9 percent from P54.5 billion in December 2022 to P63.7 billion in December 2023.

"In foreign currency terms, the

foreign exchange reserves increased from USD4.3 billion in December 2022 to USD4.8 billion in December 2023 while increasing by 9.4 percent from SDR3.2 billion to SDR3.5 billion over the same period," he

Moreover, Dekop said at this level, the foreign exchange reserves were equivalent to 8.8 months of import cover of goods and services. In the circumstances, total assets of the Bank increased

by 16.6 percent from P56.3 billion in December 2022 to P65.7 billion in December 2023.

Meanwhile, he said the monetary policy in Botswana in 2023 was conducted in the context of projected lower inflation in the short-tomedium term, in the absence of increase in administered prices (and the reduction in fuel prices); subdued domestic demand; declining trading partner countries' inflation while the economy operated below potential.

He said these conditions provided scope to ease monetary policy in support of stronger output growth, adding that consequently, the Monetary Policy Rate (MoPR)

"In response to the reduction in the MoPR, the prime lending rates of commercial banks decreased from 6.76 percent to 6.51 percent. Following the monetary policy reforms implemented in 2022, there has been a noticeable improvement in policy transmission and market interest rate structure operating as expected," he added.

Botswana up four places in competitiveness

HE INSTITUTE FOR Management Development (IMD) has released the World Competitiveness Yearbook for the year 2024. IMD World Competitiveness Yearbooks are a series of annual assessments on how well participating countries manage their competencies to achieve long-term value creation. It analyses and ranks countries by measuring key competitiveness indicators across countries (67 in 2024 up from 64 in 2023). The assessment is conducted by examining four factors considered critical in promoting a nation's overall competitiveness being Economic Performance, Government Efficiency, Business Efficiency, and Infrastructure.

Botswana improved in the world competitiveness rankings and score as revealed in the IMD World competitiveness Yearbook 2024. Botswana moved four places up and was ranked 55 out of 67 countries in 2024, improving from a ranking of 59 out of 64 countries in 2023. Similarly, Botswana's overall score improved from 45.26 out of 100 in 2023 to 50.31 out of 100 in 2024, where 100 is the highest possible

Botswana's performance in this year's IMD's world competitiveness ranking is attributable to the improvement of the overall scores of three of the four factors assessed.

The Business Efficiency, Economic Performance, and Infrastructure registered increased scores from 30.18, 22.97 and 17.50 out of 100 in 2023 to 33.39, 25.95 and 26.22 out of 100 in 2024, respectively. Government efficiency registered a decreased score of 47.38 out of 100 in 2024, down from 51.18 out of 100 in 2023. Botswana continues to do well

in the Business Efficiency factor ranking 47 out of 67 countries in 2024 compared to 50 out of 64 countries in 2023. The labour market sub-factor is the factor's greatest strength. It improved significantly from a ranking of 32 out 64 countries in 2023 to 21 out of 67 countries in 2024. Indicators contributing positively to the labour market include number of women in management (1st), percentage of female labour force (4th), stock market capitalization contribution to GDP (5th), statutory gross monthly minimum wage (6th) and compensation levels (8th). Weaknesses in the Business Efficiency factor include opportunities & threats, attracting & retaining talents, workers motivation and agility of companies ranking 64 out of 67 countries, respectively.

Botswana also registered an improvement in the Infrastructure factor rankings from 61 out 64

countries in 2023 to 57 out of 67 countries in 2024. All sub-factors of the infrastructure factor improved in 2024 except for the technological infrastructure sub-factor. Notable improvement was in the education sub-factor ranking from 51 out of 64 countries in 2023 to 46 out of 67 countries in 2024. Total public expenditure on education (1st) is the infrastructure factors' utmost

strength while its greatest weakness

is the average speed of internet bandwidth speed (67th).

The Government Efficiency factor dropped in 2024 compared to 2023. It dropped in ranking from 37 out 64 countries in 2023 to 38 out of 67 countries in 2024. The weaknesses in this factor include number of days to start a business (65th), Gini coefficient - equal distribution of income scale (62nd), inequality in the life expectancy (62nd),

Mr. Hann further noted that the Caucus has been formed to create synergy by leveraging the collective strength of member-countries, drawing on their unique experiences and resources to address Africa's common housing challenges.

Financing Africa: Where is the money?

HE Mo Ibrahim Foundation's latest report, "Financing Africa: Where is the Money?" provides a comprehensive analysis of both the financial needs deemed necessary for Africa to meet its development and climate goals and the resources that are currently available. The report makes the point that the resources mostly exist, but either lack the relevant processes to be effectively allocated where needed, or, significantly when it comes to domestic resources, are either dormant or misused. Commenting on the release of the report, Mo Ibrahim, Founder and Chair of the Mo Ibrahim Foundation, said: "We need a complete change of paradigm. This is not about Africa coming to the developed world with a begging bowl and developed countries considering how much more they can pledge. This is about smarter money, not just more money. As this report outlines, the money is already there. But current processes prevent resources from being used to properly address the challenges. Steps must be taken to reform the international financing system and update

African debt structuring, risk assessment and mitigation and aid conditionalities. Even more, our continent must stop squandering its own assets and take proper ownership and responsibility. In short, we must apply good governance to ensure these assets are adequately leveraged for the best interests of our people." The report first identifies the substantial but often incoherent numbers associated with Africa's development and climate goals. While the task of assessing financial needs is complicated by inconsistent data from multiple sources, the figures all point to staggering numbers. And whatever the numbers, the report underscores the critical need to ensure climate finance does not crowd out development finance, forcing African nations to choose between development for their population and environmental sustainability. The report then analyses financial contributions from non-African sources. Official Development Assistance (ODA) accounts for nearly 10% of the continent's financial resources. But ODA from western donors remains primarily directed towards

with specific conditionalities. Meanwhile non-DAC countries commitment to Africa is growing steadily and addresses the demand. Debt cannot be the way out, as stock and servicing costs have tripled since 2009, and its increasingly complex structure renders traditional relief efforts obsolete. Other key issues include inadequate African risk assessment and mitigation, the IMF's specific surcharges, and dormant ODA funds. But the main source could well be Africa's domestic resources, which, according to the African Union, should on average cover between 75% and 90% of the needs to finance Agenda 2063. However, most of those resources appear to be potential or dormant at best, or too often misused. Preventing leakages through Illicit Financial Flows (IFFs) could bolster resources by up to \$100 billion annually, surpassing both ODA received (\$81 billion annually) and remittances sent back to the continent (\$97 billion annually). With the average tax-to-GDP ratio in Africa still at 15.6%, half the OECD average, strengthening tax systems appears a quick win. Indeed, Africa lost \$46 billion in corporate taxes due to tax incentives in 2019, more than half of ODA received. The report also highlights the potential of leveraging remittances, sovereign wealth funds, pension funds, and private wealth. Additionally, monetising Africa's green assets including biodiversity, critical minerals, carbon-sinking potential can unlock notable financial resources, provided that good governance and allocation of resources to people's development is ensured. This report is a product of the Ibrahim Governance Forum, which is part of the Ibrahim Governance Weekend, held every year in a different African country. Scheduled to take place in Nigeria, the IGW 2024 was cancelled due to unforeseen circumstances, but the expected speakers and panellists have provided key contributions that are incorporated in the final report.

New Businesses Surge

But may be tested this year



HE AMERICAN
entrepreneurial spirit seems
to be doing well despite high
borrowing costs and consumers
burdened by high prices.

New business applications are rolling in at a monthly rate 48% higher than the 2019 average. This surge began in the immediate wake of 2020 COVID-19 lockdowns, and it continues now in both total

applications and those considered "high propensity," which are businesses most likely to result in job creation.

A flood of government funding during the pandemic, favorable programs and strong consumer demand are just a few reasons for the sustained increase in new businesses. The growth of new businesses has likely played a role in continued labor market strength, where job creation remains robust in the face of the Federal Reserve's campaign to slow inflation through higher interest rates. However, those new businesses should craft contingency plans to weather continued high borrowing costs and softening consumer spending as 2024 wears on.

Applications surge In 2019, 293,000 new business applications — as measured by requests for employer identification numbers (EIN) from the IRS — were processed each month on average. This monthly measure peaked in July 2020 at 546,000. It slowed slightly before peaking again at 503,000 in May 2021 and settling to the most recent 12-month average of 455,000.

These applications weren't solely driven by lofty fantasies conjured

during lockdowns — highpropensity applications, or those deemed most likely to result in having workers on payroll, have risen and remain aloft as well.

The increases have likely been due to a combination of factors: some new entrepreneurs being among the layoffs and business closures of spring 2020; Economic Impact Payments to households helping to seed some of the startup funding; pro-small business policies; and that difficult-to-articulate shift in life priorities that occurred because of the pandemic.

Increased filings

Early on, there was some debate as to whether these applications would actually result in successful business creation, i.e., would the ambitions of entrepreneurs translate to measures of success such as the hiring of employees? Thus far, the answer seems to be yes.

There is a lag between when a business files for an EIN and when it is measured as a new business or one where employees are on the payroll. In 2018-2019, these establishment "births" accounted for 3.1% of all establishments, each quarter, on average. That share grew to 4.3% in late 2021, and currently averages 3.6% over the past year.

You can also see the increased presence of new businesses when looking at business age data — the share of establishments younger than 2 years grew modestly from 15.5% in 2013 to 16.7% in 2019, before rising rapidly over the next several years. In

2023, the share of young businesses stood at 20.6%, according to Business Employment Dynamics data from the Bureau of Labor Statistics.

Funding Costly

These young businesses are coming of age when funding is expensive. Interest rates on new loans have roughly doubled over the past three years, according to data from the Kansas City Fed. On a loan of \$100,000, for example, this difference can mean hundreds of additional dollars on a monthly payment, and tens of thousands in interest over the life of the loan.

New small business lending remained robust in the fourth quarter of 2023, according to the Kansas City Fed, but banks report lower demand for business loans in the first quarter of this year, according to the Federal Reserve. Further, in that most recent quarterly Fed survey of lenders, a moderate share of banks report tightening standards on those loans, making it more difficult for businesses to get approved for the costly funding.

New businesses expectations The remainder of 2024 could prove tough for new businesses. Borrowing costs will likely remain high, and consumer spending could cool.

The Federal Reserve is unlikely to begin cutting interest rates until the third or fourth quarter of the year, and it will probably begin cautiously. So new businesses shouldn't expect any significant relief from high interest rates on loans through the end of the year.

In addition, the Fed's efforts to

quell demand-driven inflation with higher rates are likely to begin weighing more heavily on household finances in coming months. This means consumer demand for goods and services may not be as robust as it's been for the previous few years. In fact, it's already begun slowing, according to the most recent data from the Bureau of Economic Analysis.

New businesses are more likely to feel a negative impact from swings in consumer spending. In contrast, older businesses may have long-standing relationships with clientele — potentially greater customer loyalty — which can help buffer short-term changes in those customers' household finances. Further, more-established businesses are likely to have more resources and greater insulation to cover periods of slower business.

Owners of new businesses can prepare for the coming months by having a game plan. Businesses that depend on discretionary spending, in particular, should plan for lean times. It's better to be prepared and not need it than to be caught off guard. Think about where you might be able to cut expenses, consider a line of credit as an emergency fund and know where to go for help when you're a new business owner navigating new economic experiences.

iversity is about levelling the playing field and giving people an equal opportunity, and not about taking away the limelight from anybody else, according to Fulbright Specialist Lecturer and an expert in Diversity, Equity, Inclusion and Access (DEIA), Dr Andre Harper.

Speaking after delivering a public lecture, which was held under the theme 'Diversity, Equity, Inclusion and Access (DEIA): Success and Challenges -a BIUST Perspective' at Botswana International University of Science and Technology (BIUST) in Palapye last Tuesday, Dr Harper said if people are not given equal opportunity there is no way there can be a productive society.

Dr Harper said in his research he wanted to establish how BIUST community defines DEIA, and their understanding of the strengths and challenges facing the institution regarding DEIA. He said the challenges mentioned include not having a department dedicated to DEIA and women in leadership roles not having opportunities among others.

He commended BIUST for their successes and commitment to DEIA pointing out that one of their successes is that they were the first university in the country to graduate two (2) female PHD students one in Chemical Engineering and one in Physics.

Dr Harper also said he was impressed to see that the staff and faculty at BIUST are on the same page in terms of what is working and what needs to be implemented. "In most context the faculty and staff differ most of the times. So, it was really fascinating to be able to see that," he said.

Further, Dr Harper recommended BIUST to develop a DEIA statement, establish a DEIA

department dedicated for DEIA initiatives including programs focused on rural areas and resources for mental health. He also recommended BIUST to offer seminars and workshop to undergraduates and postgraduates, particularly geared towards the university experience incorporating the needs as outlined in the survey responses. He also advised BIUST to incorporate teaching demonstration into the hiring practices for new faculty, revamp faculty mentorship, place flyers around campus and administration building to inform students of where they can find mental health guidance and DEIA resources.

Dr Harper also recommended that BIUST provide workshops for faculty and staff to help them better understand the diverse student body and ensure that each Professor includes information about available resources and accommodation in their syllabus. He further said they should also consider establishing a computer database to identify and support students who need exceptional support services, for example disability services.

For his part BIUST Vice Chancellor Professor Otlogetswe Totolo said diversity, equity, inclusion, and access is not just a buzz phrase, but one that touches the core of the university as a whole. He revealed that BIUST has embraced diversity, equity, inclusion and access across every facet of the university, reiterating that one of their core institutional values is equality, equity and diversity.

Professor Totolo said BIUST subscribes to fair and equitable treatment of staff, students and stakeholders while also respecting their rights and differences. He said as an international university that is home to students and staff from diverse abilities, opinions, nationalities and genders, their value defines who they

are, and what they strive to achieve. "It is as a result of living this value that we have a 3:2 males to female ratio, one we actively strive to bring to balance," he said.

Furthermore, Professor Totolo said their strategic intent as supported in their 2023-2028 Strategic Plan emphasizes student centricity. He said they have made significant strides in area of accessibility for students with special needs in physical spaces, residences and teaching and learning spaces. "However, we cannot promote DEIA within the student community without ensuring the same for our staff, which is why our strategic intent in relation to high performance culture recognizes the unique contributions of staff and faculty," he said.

Professor Totolo said BIUST strives to be aligned with the national priorities around equitable access to education, and as an international university that has consistently performed exceptionally well in international rankings, DEIA matters for the university's international competitiveness. He added that with Times Higher Education ranking BIUST

No. 1 in Botswana, this project and public lecture will showcase the university's successes as well challenges in its effort to accelerate drive towards an inclusive campus environment and culture.

BIUST Deputy Vice Chancellor, Teaching and Learning -Professor Elisha Shemang said as BI-UST community they are willing to accommodate everybody. However, he indicated that as a university of Science and Technology one of the challenges they face is when people with disabilities want to do Mining Engineering, but it becomes impossible as the mines will say no. "They can't go on an attachment in the mines and go underground because if there is any emergency underground, they will not be able to get around," he said.

Professor Shemang credited the Public to the partnership and sponsorship of Fiducia Services, the first 100% citizen owned Company providing pension fund administration services in Botswana, the AVN/Square Kilometer Array Botswana and the Botswana Human Resources Development Council (HRDC).



P55m for school sport

Teachers in the dark about return of school sport

HE MINISTER OF YOUTH Empowerment, Sport and Culture Development (MYSC), Tumiso Rakgare has announced the approval of a P55 million budget by Cabinet for the revival of sporting activities in

Rakgare was speaking on Tuesday during the sending off for Botswana athletics team who are participating at the CAA Africa Senior Championship in Cameroon from 21st to 26th June 2024. He said government is hopeful that the programme will be back before the end of the current school-term. "The issue of school sport is final. We got the approval of P55 million," he said.

He said P37 million will go to

incentives, being remuneration for those who partake in the programme. He added that his ministry will in the next few days reveal the name of the revamped programme. He said the budget for school sport was initially P24 million compared to the P3 million allocated back when school sport was under the Ministry of Education and Skills Development (MoESD).

"I wish to reiterate that if this was

the sole mandate of (my) ministry alone we would have long started sport in schools but because there are various stakeholders that's why we are here today but we will continue trying so that tomorrow we can see results in our athletes," he said. Contrary to Rakgare's

announcement, Botswana Sectors of Educators Trade Union (BOSETU) Secretary General, Tobokani Rari expressed shock saying they only

learned about the P55 million through the media and social media platforms. He said they do not understand how the ministry came about the P55 million figure as negotiations are still ongoing, according to their understanding.

"We (Trade union presidents and Secretary generals) met the minister and his Permanent Secretary, Bridgete John mid -May They indicated that the mandate

of running school sports lies with DPSM, the employer of teachers. Therefore, they only asked for an ad hoc arrangement. What was presented was some form of 'competitions' to select athletes for national teams, which does not cover grassroots development of talent and nurturing in schools," he said.

Instead, technical teams representing trade unions met government representatives where they proposed compensation for participation in school sports in the form of an allowance of P1200 per month. Rari said Rakgare's announcement comes at a time when they are still awaiting finalisation on the matter. "Hopefully they will come to explain to us how they intend to go about this whole thing," said Rari.

'Target podium finish' -Rakgare

Tebogo, Ndori, Scotch, Kebinatshipi, Pesela at Africa Senior Championships

The Minister of Youth, Gender, Sport and Culture, Tumiso Rakgare has called on Botswana Athletics Team participating at the 23rd Africa Senior Championships in Douala, Cameroon to set their targets on podium finish

The Africa Senior Championship is set to take place in, Cameroon from

21-27 June 2024, while the African Beach Wrestling Championships will be held on June 22 and 23 in Dakar, Senegal. Africa Senior Championships are qualifiers for Paris 2024 Olympic Games, and as such present one last chance for athletes to qualify.

Biding the team farewell, Rakgare reminded the athletes to represent Botswana well to the best of their ability. He said in accordance with

the Botswana Sport Rewards and Incentives Package of 2022, each athlete will receive an appearance fee of P2 000.00 from the Government of Botswana for participating at the Africa Senior Championships.

He reiterated that athletes who will make a podium finish with a Gold medal will be rewarded with P50,000.00. For silver medalists the amount stands at P30,000.00 while bronze medalists will walk away with P20, 000.00 each. Those who finish in top 8 will each earn P10 000.00.

"Remember qualifying for the Paris 2024 Olympic Games will get you a P30 000.00 qualification incentive, a monthly stipend of P8,333.33 until end of August as well as the funding support build up to the Olympic Games as committed by government," said Rakgare.

He encouraged athletes who have not qualified for Paris 2024 to push their limits to qualify for the Olympics. He said Olympics podium finish offer greater incentives such as a high-cost house for gold medalists, medium cost for a silver and low cost for a bronze medalists with a cash incentive for a Top 8 finish and setting records.
