Removal of Tsheko from Mass Media complex angers some staff

### MPs to debate President, VP Benefits Bill in secret

- Internet shutdown could be order of the day when bill is debated
- Outrage as Masisi, Tsogwane families are headed for a big payout

T IS LIKELY THAT A Parliamentary session during which the controversial retired President Benefits, Pension (Amendment) Bill would be tabled and debated will be held without media coverage – as it happened when transmission was jammed during the debate on President Mokgweetsi Masisi's constituency allowance and increment of MPs salaries.

The bill proposed by the Minister for State Presidency Kabo Morwaeng has caused stir across the country, and observers say it has the potential to tarnish Botswana's image as it amounts to dictatorship and political elite's greed.

Impeccable sources at Government Enclave say the government is feeling the pressure due to criticism from the public and more so that there is now a circulating video clip in which President Masisi apologised and regretted for amending the same law in the past to suit the desires of former president Ian Khama. Masisi at the time said it was big mistake. "There are suggestions to continue with the bill despite heavy criticism on the government, but it would proceed and be tabled before Parliament. Some government officials advised Masisi that the bill could backfire more so that it is elections season and Botswana Democratic Party (BDP) can suffer," a source said. It is said that there could be internet connectivity glitches when the MPs debate the bill and that members of the public would also not be allowed to attend Parliament proceedings as it's a norm. of a similar bill in 2017 took place at night.

It is said OP is devising plans on how to explain the Parliament live beaming blackout on government media channels being Botswana Television, Radio Botswana and Parliament livestreaming platforms.

MPs late last year moved on to swiftly to pass the bill that amended their salaries and allowances, with live broadcasting of Parliament halted after which government cited technical glitches, but it was clear

Masisi has thrown caution to the wind in a brazen attempt to secure the future of his children by getting them mouthwatering benefits. Masisi is asking Parliament to approve the President and Vice President's retirement packages, that includes having their children covered with the current Vice President Slumber Tsogwane becoming the first Vice President to be covered.

This comes just a few months after he secured himself an unprecedented constituency allowance of a whopping P19 373 per month though he doesn't have a constituency. His salary was raised to P110,425, excluding allowances at the same time.

Opposition political parties and general public has reacted with shock and condemnation to Masisi's attempt at increasing his benefits at a time when the economy is facing a serious downfall. that the MPs were afraid of public criticism. MPs are expected to get another new salary increase soon. Last year, Masisi caused another stir when Parliament through BDP majority adopted a bill that proposed that he gets P20 000 constituency allowance per month on top of the high presidential perks he enjoys. Now, Masisi takes a monthly salary of P110 425.73 excluding allowances. Tsogwane's current take home salary per month is P96 864 71. In an interview, MP for Ngamiland

## **Govt denies elephant poaching claims**

 'EWB count natural death carcasses as part of poached elephants' -DWNP

LEPHANT WITHOUT Borders (EWB ) has warned that there could be rising incidents of poaching in NG15 and NG18, shortly following a report by Centre for Advanced Defense Studies (C4ADS) titled "Intercepted: Using Seizure Data to Evaluate Trends in Elephant Ivory and Rhino Horn Trafficking".

The C4ADS report links neighboring Angola and Namibia as countries with the highest number of elephant ivory seizures that continue between trans-continental Africa-to-Asia trafficking routes.

Angola and Namibia share the elephant home range that transcends neighboring states such as Botswana, Zambia and Zimbabwe. The C4ADS reports that Southern African states continue to play a key role as hubs for elephant ivory trafficking network operations.

The report indicates that the highest seizures of elephants between 2016 and 2023 were

linked to Angola and Namibia where 266 total cases were reported. The report further states that illicit wildlife trade is not a static enterprise as it is constantly evolving in response to the barriers and opportunities that arise. EWB recently wrote to

the Director of Wildlife and National Parks (DWNP) expressing concern over their inaction over allegations of 105 incidents of elephant poaching linked to ivory in the past 10 months. EWB

Director, Mike Chase expressed disappointment in the letter. "For the last ten months, I have consistently reported cases of elephant poaching to your office, yet, disappointingly, have not received any response from you," wrote Chase.

Chase reported the discovery of 19 carcasses of elephants suspected to have been poached for ivory in a well-known poaching hotspot (NG15 and (NG18). "This area has been repeatedly targeted by poachers over the past ten months.

Some of the carcasses are fresh. Poachers may still be active in the area," warned Chase, adding that the elephant carcasses clearly indicate ivory poaching as the cause of death, ruling out natural causes.

Chase said the elephant carcasses are in remote locations, far from human settlements and in photographic tourism concessions. He warned that this frequent elephant poaching for ivory and targeting of elephant bulls with large tusks continues to

be a source of worry. He said that with the recent discovery of 19 elephant carcasses seen last week, the number have skyrocketed to 105 poached elephants observed in the past ten months to 105. Chase remained resolute that they will continue to be committed in assisting the DWNP with the detection and reporting of the harmful activities of elephant poachers despite their silence and inaction. When quizzed about

allegations of rampant elephant

poaching, Public Relation Officer at the Ministry of Environment, Natural Resources Conservation and Tourism, Lesego Kgomanyane said they are currently verifying the allegations with relevant authorities.

Although he did not want to be drawn into EWB allegations that they have not been responding to poaching incidents, Department of Wildlife National Parks Director, Moremi Batshabang said: "It would be unfair to discuss what is contained in the EWB letter that Chase wrote to me in his absence".

Batshabang could not state the exact number of poached elephants in the past 10 months in NG15 and NG18, saying the numbers need to be collated to give a true picture. He said law enforcement officers are always deployed to verify poaching incidents when they are reported, reiterating that elephants that EWB claim to have been poached could be way less than 105 as reported.

"We have established that some of the incidents that are reported as poaching are not reflecting the true picture of poached elephants. We usually harvest ivory from elephants that succumbed to natural deaths and EWB could be counting those elephants as part of poached elephants," said Batshabang, adding that the number of poached elephants were far less than 105 as reported by EWB.

CIPA is spearheading initiatives to register traditional medicine practitioners and their remedies to protect their valuable assets from exploitation and ensure that local communities benefit from their knowledge and resources. By registering traditional medicines, Botswana can prevent biopiracy, where foreign entities commercialize local resources without proper compensation to the indigenous communities.

Botswana's commitment to protecting traditional medicinal knowledge is rooted in

the Industrial Property Act of 2010, which encompasses the protection of all forms of Traditional Knowledge (TK), including traditional medicine. The Act provides traditional medicine practitioners with exclusive rights to their knowledge, enabling them to prevent unauthorized use and commercialization of their products.

"The Industrial Property Act offers comprehensive protection for traditional knowledge. Practitioners have the legal right to prevent third parties from reproducing, selling, or commercialising their products without consent. This legal framework is essential for safeguarding the intellectual property rights of traditional medicine practitioners," explained Timothy Moalusi, Registrar Industrial Property at CIPA.

#### Legislative Gaps

Despite the robust legal framework, there have been significant challenges in translating these protections into tangible economic benefits. "Previously, the lack of a guiding policy hindered the economic utilization of traditional knowledge. However, the adoption of the Botswana Intellectual Property Policy (BIPP 2022) has been a game-changer. This policy is driving current projects and fostering an environment conducive to integrating traditional medicine into the broader pharmaceutical industry." said Moalusi.

The BIPP 2022 envisions leveraging traditional knowledge for economic growth by promoting research and development (R&D) and facilitating the commercialization of traditional medicine. This approach aims to create sustainable business enterprises that can contribute to the national economy.

Currently, there are no proposed legislative changes specifically targeting the protection of traditional medicinal knowledge. However, CIPA is focusing on technological advancements to enhance accessibility. "We are developing an online system for the registration of intellectual property rights, set to go live in September 2024," shares Moalusi. "This system will allow practitioners to register their knowledge from anywhere in the country, addressing the accessibility gap for those in remote areas."

The government, through CIPA, plays a crucial role in ensuring the effective enforcement of intellectual property laws. Moalusi emphasises the importance of community involvement in the creation and implementation of these laws. "We consulted local communities and dikgosi (traditional leaders) when developing the law. These consultations are vital to ensuring the law meets the needs of Batswana."

To raise awareness among traditional healers, CIPA, in collaboration with international organisations like the World Intellectual Property Organization (WIPO), has launched initiatives to train and mentor traditional medicine practitioners. These initiatives aim to enhance their understanding of intellectual property rights and the benefits of registration. integrating traditional medicine into public health systems.

#### **Success stories**

The journey of Johannes Visagie, who registered the traditional medicinal properties of donkey milk, stands out as a success story. "Visagie's knowledge has been commercialised into various products, including soaps and lotions. This case exemplifies how traditional knowledge can be protected and commercialised, creating sustainable businesses," notes Moalusi.

Botswana collaborates with international organisations such as WIPO and the African Regional Intellectual Property Organisation (ARIPO) to develop and implement effective IP protections. "The recent WIPO treaty on Intellectual Property, Genetic Resources, and Associated Traditional Knowledge marks a significant milestone," says Moalusi. "It ensures that indigenous communities are protected from misappropriation when their traditional knowledge is used in new inventions." Botswana also looks to best practices from countries like China, India, and South Korea, where traditional medicine is successfully integrated into mainstream medicine. These countries have demonstrated that traditional knowledge can be commercialised on a global scale.

#### **Future Prospects**

Looking ahead, CIPA envisions an ecosystem where all traditional medicine practitioners register their knowledge, supported by a cohesive government framework that fosters research, branding, and market access. The ongoing project with 25 traditional medicine practitioners is a testament to this vision. "Our goal is to develop a sector that contributes to economic growth and diversification. The practitioners are responding positively.

We aim to see their products on pharmacy shelves locally and internationally, which will enhance their livelihoods and create employment opportunities," Moalusi explained. Dumisane Keika of Dimata Dingaka and Leobo la Dingaka expressed gratitude to CIPA for the workshop lessons on IP and said that as traditional medicine practitioners their relationship with Ministry of Health is growing steadily as they are often invited for discussions and ideas exchange between them. He says that the COVID19 pandemic proved that a lot of work needs to be done in bettering relationships between them and the Ministry of Health as there was visibly a lack of connectedness which prevented them from contributing their ideas and skills in the effort to deal with the pandemic. "Our wish is to have an open and transparent relationship with both CIPA and the Ministry of Health so that in future we are better prepared and ready to deal with pandemics such as the COVI19 should the need arise as a unit without one part pulling the other direction while the other pulls in a different direction," he stated.

#### Landmark development

In a notable event held in Gaborone from July 24-26, 2024, the IP and Traditional Medicine Project was officially launched, marking a significant milestone in Botswana's journey towards a knowledge-based economy. Joel Ramaphoi, Caretaker Registrar General of CIPA, highlighted the project's genesis and its pivotal role in strengthening Botswana's IP ecosystem. Ramaphoi shared, "This project commenced in April 2024 with the appointment of consultants who engaged key local stakeholders to gather information about the status of traditional medicine practices in Botswana. The warm relations between President Masisi and WIPO Director General Daren Tang during a 2023 visit to Geneva were instrumental in the conception of this project."

He further acknowledged the support of the Minister of Trade and Industry, Mmusi Kgafela, and the involvement of international experts from WIPO, including Siddhartha Prakash and Fei Jiao, who provided valuable insights. The presence of distinguished speakers from Ghana and Ethiopia underscored the collaborative spirit of the event, as they shared their experiences in As Botswana moves forward with this ambitious project, the protection and commercialization of traditional medicinal knowledge promise to unlock new economic opportunities, ensuring that the rich heritage of traditional medicine continues to thrive in the modern world.

Traditional medicine in Botswana has a deep-rooted history, with an estimated 3,100 practitioners, predominantly in rural areas. Despite this, the integration of traditional practices into the mainstream healthcare system has been limited. Efforts are underway to change this narrative. The Ministry of Health has underscored the importance of scaling up the use of traditional medicine, especially given its potential to address a variety of health issues alongside conventional treatments. The World Health Organization (WHO) has also highlighted the importance of traditional medicine in its strategy for 2014–2023, encouraging countries like Botswana to explore and validate these natural remedies for broader use. This aligns with the recent National Health Research Symposium in Gaborone, which emphasized the need for increased research and development in this sector.

Caterpillar Hikuama said the MPs are not aware if there is a plan for the President's Benefits Bill not to be debated in cameras, but said if it so, it will be a dark episode of Botswana's history and democracy.

"Before one can throw in his views regarding the pension for the President's adopted children, it is imperative to understand, one, what triggered the thinking or though, two, what are the past experiences that necessitated the law, and what is it that we want to achieve by this kind of law," he said.

Hikuama said failure to get answers to the above questions, one will only be left to speculate and conclude by saying that its only a law influenced by greed and selfish.

He said not so long ago, the nation witnessed Masisi crying for being given a constituency allowance of P20 000 per month, adding that such was promulgated and has been enforced.

"What can you term this, if not greedy or abuse of power by the current president Masisi regime," he said.

Questions sent to the Press Secretary to the President Masego Mosate had not been answered at the time of going to print.

The proposed amendments of the bill are

that children of presidents and vice presidents as starting from 2019 should benefit from presidents' pension and retirements salaries that are not subjected to taxation.

The bill reads that the spouses of former presidents should also benefit from the president's pension and retirement benefits post the presidency and further notes that even if the retired president passes away his or her children and their partners should continue receiving the welfare from the retirement benefits.

The Leader of Opposition in Parliament (LOO) Dithapelo Keorapetse said the bill shows Masisi's greed.

Keorapetse said Masisi's greed is on steroids and that he has absolutely no iota of decency, adding that the law must be rejected as it is embarrassing, unreasonable and huge cost to taxpayers. As the UDC in Parliament, Keorapetse said they are not surprised at all by the bill because Masisi has exuded greed since he has ascended to the high office of president.

"He has allocated himself a state farm, he recently sponsored a law to pay himself a constituency allowance when he has no constituency and he is taken care of by the state including transportation, accommodation and food," Keorapetse asserted.

## Man and his money: The uneasy romance

N A SHORT SPACE OF NINE months - October 2023 to July 2024 – Masheleng's Facebook page has seen a 200 per cent jump in followers from 50 000 to over 150 000. Their Tik-tok account has equally grown swiftly to over 70 000 followers. As you read this, the numbers would have changed drastically.

Seatla Ratshosa is a much sought after man for his electrifying, inspiring and eye-opening discussion on personal finance – addressing the over-indebtedness disease that is driving some locals to mental breakdowns and civil imprisonment.

The country's household debt stood at P68.5 billion as at December 2023.

He rightly compares himself to a church pastor. "I have to repeat my message over and over again for people to begin to understand and change their relationship with money. At the beginning I told people this will be a 40-year project. I believe it will take this long to begin to see the fruits of my work when our people's relationship with money improves," he enthuses.

Operating under IGNYTWealth, Masheleng serves as a vital arm, bolstering IGNYTwealth's mission to educate and empower the masses through innovative digital content creation.

#### COMMUNICATION

To make his business appeal to reach fever pitch, Ratshosa realised that engaging only the privileged elite was not sufficient. He changed and repackaged his communication strategy. He eased off; cut the uptight-ness and engaged in both English and Setswana; almost as casually as in any natural conversation. He engaged on common matters that affect individuals and families when they make money decisions.

It is only after one has built investments that are able to sustain him/her that he would be in a position to offer a hand to others who need assistance. Ratshosa envisions a future where Personal Finance Education will be part of the learning culture in schools. 
While their programme has become a hit locally, they are well aware of the limitation imposed by the limited market. For this reason, they have already started offering their services in South Africa.

## 6 News 'I was abused and forced to exit'

#### **\*HON THAPELO MATSHEKA** (PHD)

. Honorable Speaker and Members of this House as per standing order 43.1 I approached the office of the speakership to seek consent to deliver a personal statement. I met with the Honorable Speaker, on the 31st July 2024, to share the personal statement that I wished to make as per the rules of the house and was granted permission to make the statement as I hereby do.

2. Mr. Speaker I am making this statement as I noticed consistent and passive references to the events that happened to me and the various innuendos made in defense of an injustice done to a Citizen of Botswana and a Member of the National Assembly of Botswana. I think such incidents cannot be defended by any Member of Parliament nor the Executive or Cabinet.

Today marks exactly two years since my arrest by the Directorate of Intelligence and Security Services. I took an oath in this august house to defend and protect the Constitution of Botswana in order to ensure the peace and tranquility of Botswana. We all love our country irrespective of the positions we occupy in society.

I would like to put it on record that I am nearing the end of my term as a Member of Parliament for Lobatse Constituency and will not seek reelection back into this Honorable House. In economics its free entry and FORCED exit. I was abused and forced to exit.

I want, once again, to thank the young and old people

of Lobatse for the faith that they placed on me to be their Member of Parliament. Little did they know that it would be the same people that they had put in power who would cause me pain and frustrate the developments that we had planned for our town? I will use any opportunity to thank you the People of Lobatse whilst in this House and beyond. Mr. Speaker I was born and

raised in a democratic and peaceful Botswana. I would like future generations to repeat these words and confirm that we bequeathed a healthy and vibrant democratic state where there are no threats to one's life when they hold a different view from others and even to authority.

It can never be in a democratic state where people and even representatives in this house are afraid to participate in a debate or differ. We are citizens first and then we can belong to any formation legally recognized.

Just for the record Mr. Speaker I was born in Mahalapye exactly where the bus rank is now situated. I also had the privilege of growing up in Kazungula when my late father was working in Kasane. I spent my youth days in Lobatse and Molepolole. I stayed at Mokgalong ward at Rre Mahatelo's house and completed my secondary education at Kgari Sechele 11. Molepolole is my second home. My mother worked at the Cooperative Store in Molepolole.

I have never at any stage of

my life been suspected nor asked to account for any wrong doing. I still do not do any wrong to warrant arrest by law enforcement let alone the DIS. I have lived peacefully and contributed to this economy and country for the last 40 years. I am still contributing

and hope to set an example to young people to follow in my footsteps and not succumb to hatred and jealousy. To young people of Botswana "Your future is in your hands".

I have never at any stage of my life been suspected nor asked to account for any wrong doing. I still do not do any wrong to warrant arrest by law enforcement let alone the DIS

Mr. Speaker (two) 2 years ago, on the 2nd of August to be precise, after attending a virtual meeting of Parliament members of the DIS stormed my house with sirens and a lot of cars to arrest me. I asked them why they were at my house and they refused to state the reasons and only said that I shall hear when we get to their offices at Sebele along the Francistown road. They further refused with their identity stating only that the DIS ACT protects their names

and identity. We all know them. There was a young man that I had sent to do errands for me whom they also arrested and was told equally that he will know why he is also being arrested. It was indeed strange in our country. They also arrested a lot of my network of friends and subjected them to torture and abuse seeking to force them to implicate me in their plan. It is important to surround oneself with men and ladies of principle. Sellouts feed out of dead carcasses.

I had actually heard way before that there was a plan to do this the way they did it. I did not believe that this could happen in this country. But then again many have been arrested before and denied freedom only for nothing to happen.

The culture of falsifying or fabricating charges or arbitrary arrest should not be acceptable for any reason even political. Any system holding itself to the highest standard of the rule of law would not be so silent on the face of all that has been happening to citizens at the hands of the DIS. The silence beats me as well many who hear statements about the commitment to the rule of law.

The whole situation started weeks before with the Director of DIS addressing Kgotla meetings in Lobatse and the District Commissioner not alerting the office of MP of the meeting. The DIS, Mr. Speaker, is responsible for the riots and damage to property that took place in Lobatse.

Mr. Speaker the principle of separation of powers is the corner stone of a democratic

and rights based constitution. It is designed to restrict over reach by the different arms of government. I stand here Mr. Speaker a direct beneficiary of this basic principle. I witnessed, as did the whole country and indeed the whole world, when it emerged that there were attempts to influence the court process to have me detained illegally.

There were alleged calls that were made to a Judge of the high court by a member of the executive seeking to influence them to pass judgment away from the law. It was even scary for me when the judge made allegations against the Chief Justice.

The Law Society joined the fray to voice against such conduct as unacceptable to say the least. It is unknown what action was taken save to say a deal has clearly been made to sweep the matter under the carpet. There was no judicial inquiry into this grave matter. It is business as usual Mr. Speaker. There is no rule of law.

These type of things should receive the scorn of all those that profess to protect and defend the constitution of Botswana. Where are the addicts of the rule of law when these happen within government? Why do these things go unpunished in our country? They must receive the strongest condemnation from all proponents of the constitution. They should never be rewarded as they currently

ADAM PHETLHE ON SUNDAY!

HE FORMER VICE PRESIDENTS (Pensions and Retirement Benefits) Bill No 13 of 2024 is set to be debated and concluded in the current meeting of the National Assembly. It is the first time in Botswana's political history that retirement benefits are created for a former Vice President by the Botswana Democratic Party (BDP) government on the eve of a general election. It is the political optics and the timing of this Bill that has attracted so much attention.

By the time the National Assembly is dissolved and Batswana ready themselves to elect the next government, this Bill would have been signed into law with the commencement date determined. There will always be many conspiracy theories thrown around and one such is that His Honour the Vice President Slumber Tsogwane could be relieved of his position after the 2024 general election in the likely event the BDP wins it. It is hard for me to outrightly dismiss this conspiracy theory. The VP's boss His Excellency M.E.K. Masisi has publicly given conflicting statements on the VP's position. At one point, he says the VP is his chosen man while on the other side he says he has not promised anyone any position. This doublespeak certainly brings in uncertainty and confusion not least to the VP himself.

Context is always important and so it does to the matter under discussion. During the former President Q.K.J. Masire's administration, the BDP was at some point during his administration undergoing some level of internal political strife owing

to palpable factional battles. The factional battle was precipitated by the desire of either faction to have the control of the party. As a compromise to stabilise the party, Q.K.J devised the current automatic succession plan where the sitting Vice President automatically succeeded the outgoing President. In fact, it was Q.K.J's condition that he stepped with Rre Festus Mogae taking over from him.

This dispensation was adopted by the BDP in 1995 and incorporated into the country's Constitution in 1997 hence the Vice President of the Republic automatically succeeding the sitting President after the mandatory two-term threshold. Former Presidents Festus Mogae, Ian Khama and Masisi have benefitted from the automatic succession dispensation with Tsogwane looking forward to do the same when Masis's second term expires. In the past, there has not been any controversy to smooth transition from the outgoing President to the incoming Vice President to assume the office of the President of the Republic. But there is a possibility flowing from the irresistible conspiracy theory I have alluded to above that this smooth transition from Masisi to Tsogwane could be disrupted through a 'palace

coup' of sorts. And this 'palace coup' will be effected by the former not appointing the latter to the position of Vice President. Should this conspiracy theory come to pass, Tsogwane will be out in the political wilderness.

To ensure he does not fall on hard ground, the BDP has moved mountains to ensure Tsogwane softly lands with minimum damage to his political ambitions hence the hastily crafted mouth-watering former Vice Presidents (Pensions and Retirement Benefits) Bill No 13 of 2024. The retirement benefits for Tsogwane will include inter alia: (a) tax-free monthly pension equivalent to (b) the monthly basic salary attached to the office at the time he ceased to hold office OR, 75% of the incumbent VP's salary whichever is greater; (c) staff benefits which includes six security officers, office accommodation; medical care, transport which includes five motor vehicles and funeral cover which includes State funeral benefits for himself and his spouse; (c) benefits to his dependent children born in and out of wedlock. These benefits, by and large, do not differ substantially with those of the now enhanced former Presidents'. Will these benefits be attractive enough to persuade

Tsogwane to let go of his political ambitions of being the next President after Masisi vacates office in the event the BDP wins in October?

Is the retirement benefit for VP created for his soft landing?

It is difficult to tell at this stage. But I must make this point before it escapes my mind. It will be grossly unfair for Masisi to break the tradition he himself benefitted from by dropping Tsogwane. The argument proffered for the likelihood of dropping him is borne out Masisi's desire to appoint a woman VP. There could be some truth because Masisi has upped the ante in appointing women to key leadership positions. I argue he had the opportunity to do so immediately he became the President because there were a

number of women to choose

from. It is further argued Tsogwane wanted to leave active politics at the end of Khama's administration and was persuaded by Masisi to stay on. In the public eye, Tsogwane has routinely and viciously defended Masisi with all he has; just as Masisi defended Khama. This is the loyalty Masisi desperately requires from those around him. I am not oblivious to the saying that there are no permanent friends but permanent interests in politics. But to have 'used' Tsogwane and dump him when he is a stone away from the ultimate ambition of any politician is grossly unfair as I have said. I don't think Tsogwane will be persuaded by the retirement benefits to let go of his biggest political ambition to be the President of the Republic. Expectedly, he has built support within the BDP structures where any attempt to dislodge him from the presidency could resuscitate the otherwise quiet factions.

is to retain his parliamentary seat failure to which that ambition will be as good as gone. He will take comfort in the fact that he has won that constituency ever since he became an MP and crucially, that his constituents will double their efforts to ensure he wins comfortably in October. Bear in mind that he faced stiff competition from an opposition candidate in 2019.

While on the face of it retirement benefit for former VPs is not a bad thing barring in my view, the excessive and obscene benefits, it obtains in other democracies. The timing and political optics of the one under discussion are not far off from the view that it was crafted as a soft-landing pad for Tsogwane on account, as the conspiracy theory goes, that he is on his way out. Something hard-to-ignore package had to be quickly created otherwise it would have been a significant departure from the finer things of high office resulting in him falling on hard ground. The results of the General Election and the composition of Cabinet with respect to the BDP in the event it wins will give me a hint of where Tsogwane's fate lies. I am prepared to be persuaded otherwise as always. Judge for Yourself! <u>adamphetlhe08@gmail.com</u>

## Botswana must learn from UK free and fair elections

PART 2

HIS WEEK, WE SHALL CONTINUE OUR discussion on how the UK recently carried out its general election and the feelings of rival political politicians in its aftermath. The transfer of power from the outgoing Conservative administration to the incoming Labour administration after the election was orderly and peaceful. The first results started trickling in at around 11.30 pm, just one and a half hours after the polling stations had closed. At around 5 am on 5th July - the day after the election – Rishi Sunak conceded defeat to Sir Keir Starmer even before Labour had officially secured a majority of seats (326). In his resignation (as Prime Minister) speech later that morning outside the official residence of all British prime ministers – 10 Downing Street, Sunak apologised to Conservative voters and those parliamentary candidates who had lost

their seats in the election. He told them that he has heard the voters' anger and disappointment and that they have sent a clear signal that the government of the UK must change. Furthermore, he told them that he takes full responsibility for the cataclysmic collapse of the Conservative vote in the election. His words were also echoed by those Conservative candidates who had lost their seats and cabinet posts - "we have failed and have let you down." Sunak continued by saying: "Whilst he has been my political opponent, Sir Keir Starmer will shortly become our Prime Minister. In this job, his success will be our successes and I wish him and his family well. Whatever our disagreements in this campaign, he is a decent public-spirited man who I respect. He and his family deserve the best of our understanding as they make the transition to new lives behind this door and grapple with the most demanding of jobs in an increasingly unstable world." His speech showed that Sunak offered support to the new prime minister and expressed hope that he would be successful in carrying out his mandate – let us get behind him! Shortly afterwards, Sunak left Downing Street for the last time. He was driven to Buckingham Place, the official residence of the reigning monarch, King Charles 111. Here he was ushered into the presence of the King for a private audience fit for the two most powerful figures in the land – head of state and head of government. Sunak then asked the King to accept his resignation as his prime minister. The King accepted and immediately Sunak was no longer the prime minister of the UK. In doing so, Sunak had passed government power to the King who now held the reins of government. He then asked Sunak who should be the next prime minister and he replied saying Sir Keir Starmer. Once Sunak had given his answer, palace staff then immediately contacted Starmer inviting him to the palace for an audience with the King. Within an hour, Starmer arrived at the palace where, during a private audience with the King, he was asked if he could form a government. Starmer replied saying that he could do so. At that moment, the king passed on government power to Starmer who automatically became the next prime minister. Believe it or not, not a single document was signed during these audiences! And the procedure went so smoothly without a hitch. Starmer then was driven to Downing Street where he addressed the world media for the first time as prime minister. In his speech, Starmer was gracious enough to pay tribute to Sunak saying "His achievement as the first Asian Prime Minister of our country should not be underestimated by anyone." And he also recognised "the dedication and hard work he brought to his leadership." Starmer then continued by saying that he invited all to join his government of service to the country.

Plus, he held a press conference. So, we can see that the whole electoral process and the transfer of power took place in just two days!

And the morning of the following day, 6 July, the new Cabinet met for the first time. The first meeting of the new Parliament took place on July 9, during which the Speaker was elected. As MPs left the chamber, Starmer and Sunak walked side by side along the aisle during which time Starmer laid his hand on Sunak's shoulder, the two men engaging in light polite conversation. Later, MPs were sworn in by oath. One week later, on July 17, the State Opening of Parliament took place, a ceremonial event which formally marks the beginning of the new session of parliament. At its core was the King's speech and only after then can parliamentary business proceed. From this article, we can see the amount of courtesy and respect that was shown by the outgoing prime minister towards his successor, and vice versa. They also showed humility, especially Sunak who admitted that he was largely to blame for his party's poor performance in the election and did not pass the buck onto someone else. Instead, he said that the buck stops with him. Hence, there were no bad feelings between the two politicians. Both men believed that this was so necessary for stability and unity in the country. But in Botswana things are very different. In the 2019 general election, Duma Boko's UDC lost to President Masisi's ruling BDP. However, at the time Boko showed a cordial dislike for the president; also, he was not willing to swallow his pride, become more humble, and take any responsibility for his party's defeat in the election. Instead, after five years he still continues to pass the buck for his loss by insisting that the elections were rigged in favour of the BDP, even though he has up to now not provided any hard facts to back up his claims. Boko cannot cry over spilt milk forever; the 2019 elections are now history. What a contrast to Rishi Sunak! And Boko can also learn something from South Africa's recent election in which the ruling African National Congress government lost much support, especially to the recently formed uMkhonto Wesizwe [MK] party led by former president, Jacob Zuma. Unlike Boko, South African President Cyril Ramaphosa has admitted that his party must share most of the blame for the marked drop in the ANC vote in the election. In 2018, Masisi succeeded former president, Ian Khama, as head of state. Since then, we have seen a bitter feud develop between the two men which shows no sign of abating. Instead, Khama shows no degree of respect for Masisi as head of state and, in spite, formed a new political party, the Botswana Patriotic Front (BPF). He has also labelled Masisi a liar and coward and tries hard to destroy the BDP, the very party that his father, Sir Seretse Khama, worked so hard to set up before independence. Furthermore, Khama has run Botswana down by visiting foreign Western embassies and countries in an attempt to show

Masisi's administration in a bad light and so discourage foreign investors from investing in Botswana. Khama remains a bitter man and holds a grudge against Masisi. What a contrast

That said, his biggest hurdle

**B** OTSWANA PUBLIC OFFICERS Pension Fund (BPOPF) has seen its assets value jump 15 percent in 2023-24 to reach P108 billion from P94.7 billion.

BPOPF Chief Executive Officer (CEO) Moemedi Malindah said this growth speak to how great the year was for them in terms of performance, adding that in 2024 the pension fund has paid P4.3 billion in benefits.

According to Malindah, the local equities have been the main driver of growth as they realised P16 billion growth in 2023-24 as compared to P13 billion in the corresponding year.

On the other hand, the offshore equities value was P59.7 billion; signaling 11 percent growth as compared to P53.9 billion in past year.

for members who are closer to retirement," said Macholo.

She said BPOPF maintains a strong funding ratio of 100.08%, demonstrating its ability to meet current and future obligations, adding that effective cost management practices have enabled them to optimise operational efficiency, ensuring maximum value for the Fund members.

CCORDING TO BOTSWANA'S central bank data, sales of rough diamonds at Debswana Diamond Company fell by 49.2%, amounting to \$1.29 billion compared to \$2.54 billion in the same period last year.

In local currency, sales of rough diamonds

The report highlighted the downturn in the global diamond market as the primary reason for this sharp decline.

In response to the weak consumer demand, Anglo American cut its diamond production by 19% in the first six months of the year.

Botswana derives 30%-40% of its revenue, 75% of its foreign exchange earnings, and a third of its national output from sales of rough diamonds.

Reuters reported that the company also revised its output guidance for De Beers down to 23-26 million carats from the previous 26-29 million carats.

The Debswana Diamond Company is a joint venture between the government of Botswana and Anglo American Plc's De Beers. Anglo American Plc's (AAL.L) De Beers sells 75% of its output to De Beers, while the balance is taken up by the state-owned Okavango Diamond Company (ODC).

Despite the current economic challenges, Botswana and De Beers signed a ten-year diamond sales agreement in June.

This deal will gradually see the share of Debswana's output sold by the state-owned company (ODC) increase from 25% to 30% before it goes up to 40% in five years and eventually 50% by the end of the new contract.

### Botala Energy gets 100% ownership of Serowe CBM Project

The company announces takeover of remaining 30% stake

The Botswana Stock Exchange (BSE) listed energy company, Botala Energy Limited has announced that it has taken the full ownership of the multimillion Serowe Coal Bed Methane (CBM) project.

The energy company revealed in its quarterly update report this week that it has increased its investment in the project by acquiring the remaining 30% of Serowe CBM Project.

Located in Serowe in Central District, the CBM project consists of 420,000 hectares of prospecting licenses in the Karoo-Kalahari Basin.

Botala Energy has identified an independently certified 2C Resource of 454 billion cubic feet (bcf) in the immediate vicinity of 11 wells drilled within these tenements, and a total prospective resource of more than 7 trillion cubic feet (tcf) within the total area of the Serowe project. Commenting on the new developments,

the CEO of Botala Energy Kris Martinick said the quarter under review has been transformative for Botala, highlighted by their strategic acquisition of the remaining 30% interest in the Serowe CBM Project.

He said this consolidation significantly enhances their operational control and positions Botala Energy optimally to attract development partners.

According to Botala Energy, this strategic acquisition consolidates their asset base in Botswana, enhancing operational control and increasing potential revenue from the project.

It said the consolidation is crucial for engaging prospective strategic partners and positioning Botala favourably to potentially

farm-out a portion of the recently acquired stake to a major development company (though for completeness, no binding terms have been agreed and there is no guarantee that any such transaction will materialise on terms favourable to Botala, or at all). Solar Partnership

Meanwhile, the company said it has signed a binding Heads of Agreement (HOA) with AAAS Energy BV to develop 250MW (Stage-1 of this 500MW solar project) of solar photovoltaic capacity at the Leupane Energy Hub and Industrial Park.

It noted that pursuant to the HOA, AAAS will farm-in to 50% of the project by contributing A\$1million on development costs, including a Bankable Feasibility Study (BFS) and to a Final Investment Decision (FID).

"They will also assist in securing future funding. This arrangement allows Botala to advance significant opportunities without incurring initial project development costs, and leverages AAAS's extensive solar project development expertise," Botala affirmed.

Looking forward, Botala Energy said it remains committed to advancing its flagship Serowe CBM Project and related renewable energy initiatives.



## Botswana in a fix over De Beers after Anglo's exit move

T INDEPENDENCE IN 1966 BOTSWANA was one of the world's poorest countries. There were just 12km of paved roads; 22 Batswana had graduated from university and 100 had completed secondary school.

In 1967 De Beers geologists discovered diamonds, which have generated the resources to finance the country's economic growth miracle. From 1967 to 2008 Botswana's economy grew by 8.8% a year. Yet the country still has a high unemployment rate and has suffered from "Dutch disease" — a failure to diversity from diamonds. Botswana is now at a pivotal moment in its history after Anglo American's decision to exit its investment in De Beers through a sale or listing. The government of Botswana has no option but to increase its stake in De Beers while the country's trend GDP growth rate has collapsed and the long-term prospects for the industry have deteriorated sharply, partly due to growing competition from synthetic diamonds. From 2009 to 2023 the GDP growth rate plunged to 3% a year, but Botswana is still Africa's third-richest country after Mauritius and Gabon, with a GDP per capita of \$7, 738. The government has legal ownership of 15% of

## The Manufacturing Industry: An integral cogwheel in Botswana's future

FOCUS ON DEVELOPING LOCAL manufacturing capability is key towards driving economic diversification in many commodity-based economies across the continent. This is particularly important as commodities are often finite resources which operate in specific cycles where demand and price can vary significantly impacting sustainable economic development. To this extent, manufacturing is a critical sector as it aides in providing employment opportunities, developing local skills base, driving revenue from exports and building local supply chains. According to the World Bank, Botswana's manufacturing sector contributed approximately 5.6% to the country's GDP in 2023 and remains modest due to a limited domestic market and heavy reliance on imported supplies. The Botswana government has however implemented several initiatives to stimulate growth in manufacturing sector and enhance competitiveness.

The Industrialisation policy coupled with the Economic Diversification Drive focus on diversifying the economy away from mining dependence and includes measures to support the manufacturing sector. There are various training and capacity building interventions such as the Technical and Vocational Education and Training (TVET) curriculum, which supports many an Industry including manufacturing.

Lessons learnt from countries with high manufacturing output such as China and India highlight the following key attributes are required to cultivate a successful manufacturing environment which Botswana and any other country with similar aspirations needs to consider.

A stable and continuous energy supply is fundamental for manufacturing operations. Interruptions in energy availability can disrupt production processes, leading to costly delays, and damage of essential equipment. In Botswana, the energy sector is expected to be bolstered by the Independent Power Producers (IPPs), who have become an important part of the generation mix, providing additional power to the grid which then subsequently supports Industry.

Proximity to or easy access to raw materials is important for minimizing supply chain disruptions and reducing transportation costs. Efficient logistics and well-developed understanding the manufacturers' working capital cycle as well as offtake agreements to ensure financing is provided across the entire value chain. Governments can also play a role in attracting Foreign Direct Investments to bolster the manufacturing sector through political stability, policy certainty and incentives such as tax breaks.

Big picture thinking, investment in infrastructure, skills development, leveraging trade agreements will all be required to drive manufacturing in Botswana and across the continent at large. At face value, it may seem easier to continue to import goods from developed nations with proven track records of delivery of quality goods at affordable prices. The question is, what is the opportunity cost of continuing to do this?

Next Areas of Focus for the Manufacturing Industry in Botswana

As the economy looks to tilt from heavy dependency on mining and government as the Country's biggest employer, the manufacturing industry stands a great opportunity to be the key driver of this economy going forward. Some of the most opportune spaces to invest into as a way of supporting this industry include.

Developing a value-added agricultural products environment, or simply put agroprocessing space is a key area worth considering by the manufacturing industry. This involves processing raw agricultural products into finished goods, which can increase their market value and create new revenue streams. The recent vegetable importation ban by the government also supports the agro-processing industry due to the increased supply of produce that is also easily accessed by those in industry.

Adding value to the country's rich mineral resources through processing and manufacturing can significantly boost the sector. The buzzword here has been mineral beneficiation which includes activities such as cutting and polishing diamonds and other minerals. The pharmaceutical industry is also one growth area to be considered in the manufacturing space. The local production of pharmaceuticals, including ARVs, has been identified as a significant growth area. This can help meet local demand and reduce import dependency.

At some point, Botswana had a thriving textiles and apparel industry that was supported by the Africa Growth & Opportunity Act (AGOA). This largesse that was extended by the United States government to Botswana and other African countries including Lesotho and Eswatini, went a long way in helping set up a thriving industry. This was however not fully optimised as the local industry collapsed due to importation of cheaper goods and a burgeoning Chinese market that positioned itself as the textiles and apparels hub of the world.

Keith Jefferis, an economist who used to be deputy governor of Botswana's central bank, says De Beers is a unique mining company because it also has expertise in marketing and sales. An ideal partnership would need to combine three skills sets: mining, marketing and sales, and finance. But De Beers is probably too small to attract the mining majors. And Russian company Alrosa, which is under sanctions, is the only other large diamond producer. A vanity purchase by a luxury goods company or a sovereign wealth fund would add little value to De Beers. There has been talk of a return of the Oppenheimer family, but getting back with the ex is seldom a good idea. A possible way out of this predicament is for the government of Botswana to go it alone with the current management team, which is led by respected CEO Al Cook, and

which is led by respected CEO AI Cook, and exchange its 50% share in Debswana — which accounts for 77% of group production — for a share in De Beers. "This would be a share swap and no cash would change hands," an investment banker says.

According to the latest Anglo annual report, De Beers' economic interest in Debswana is 19.2%. Therefore, the Botswana government's economic interest in the joint venture is 83.7% and Anglo's is 16.3%. The difference between legal and economic ownership is probably due to the taxes and royalties Botswana receives in addition to dividends. This means the government's economic interest in De Beers is 64.4% using production figures. The difference between Anglo's 85% legal ownership and its 35.6% economic interest in De Beers may be another deterrent to a direct sale. A dilution of Botswana's voting rights in Debswana in exchange for control over a larger group that also has mines in SA, Namibia and Canada would be a small price to pay to get such a historic transaction over the line and create a new African diamond champion headquartered in Gaborone.

The downside is that the volatility of the diamond industry may require periodic cash calls on the government of Botswana and make it difficult to make the new De Beers an attractive proposition for a listing on the JSE. [businesslive. co.za]

infrastructure are crucial for the seamless movement of raw materials and finished products. Botswana being a land-linked country will need to invest in rail, road and warehousing infrastructure to enable efficient transportation of goods predominantly to and from ports within the region such as Mozambique, Namibia and South Africa. The recent signing of the landmark agreement for the development of the new Techobanine deep water port in Mozambique and the Limpopo Railway Line which will run across Zimbabwe and connect Botswana and Mozambique is certainly a step in the right direction. The quality of the workforce is pivotal to manufacturing success. A skilled labour force, equipped with the necessary technical expertise and knowledge, enhances productivity, ensures high-quality output, and drives innovation. Investment in education and vocational training is essential for developing a capable workforce that is skills ready and adaptable to the everchanging technological advancements of today. Over and above this, it is also necessary to attract the right skills into the market and immigration policies need to support this.

Embracing advanced technologies and fostering a culture of innovation are essential for maintaining a competitive edge in the manufacturing sector. Integrating innovative technologies, such as automation and digital tools, improves efficiency, enhances product quality, and drives technological advancement.

With an existing global dominance of manufactured goods from Asia, Europe and the America's, careful consideration needs to be made about the sectors, markets and goods to target for manufacturing. The mining sector, which is currently the largest contributor to GDP in Botswana could act as catalyst for growth of manufacturing as it has a large value chain which requires a diversified range of manufactured goods ranging from chemicals and lubricants, protective clothing through to specialized equipment. With strong support already in place to support local buying in the sector, further investment into manufacturing capability makes sense. Mining is also the dominant economic driver in neighboring countries including South Africa, Zambia and Zimbabwe and through trade agreements such as Africa Continental Free Trade Agreement there could be an opportunity to develop a regional market to support specific products manufactured in Botswana for use in mining value chains.

Funding for manufacturing activity will need to be supported by various players across the ecosystem. Developmental Financial Institutions will play a big role in providing the capital required for start-up projects via debt, equity or grant funding. Banks will need to focus on Now armed with deliberate localization policies like CEEP, Absa Bank Botswana is of the view that this industry can be resuscitated to play its part as a key employer through encouraging the manufacturing of textiles and garments like school uniforms, PPE wear for the mining industry, and other related items as local production is now supported due to import restrictions in place.

#### Strategies for local businesses to penetrate International Markets

With the above achieved, there will also be a need for the local manufacturing industry to have a global view eventually. Certain strategies will need to be employed for local businesses to scale up and be able to penetrate the international markets. Enhancing product quality and standards is key to being competitive. Local businesses must ensure their products meet international standards. This can be achieved through certifications, quality assurance processes, and continuous improvement in manufacturing practices.

Adopting advanced manufacturing technologies and investing in research and development (R&D) can increase efficiency, reduce costs, and create innovative products that appeal to international markets. Utilizing Special Economic Zones (SEZs) like the Selibe-Phikwe Economic Diversification Unit (SPEDU) can provide businesses with incentives, better infrastructure, and simplified regulations, helping them scale up operations.

Businesses should actively seek opportunities in regional and global markets. This includes participating in international trade fairs, building networks with foreign buyers, and understanding the market demands of target countries. This speaks to export market development, a key component in aiding local manufacturers to be global players. We believe that with these strategies in place, not only will the Botswana manufacturing industry grow and be a significant contributor to the GDP, but the industry will also open the country up to opportunities of FDI as other more established economies seek growth and partnerships will be looking at those countries that have well laid policies that support industry.



## DTCB powers swimmers

**WW** E GATHER HERE TODAY TO MARK a significant milestone in our journey, one that promises to elevate the sport of swimming to new heights. This year, BSSA is celebrating a very BIG year, after it was registered as a Society at the Registrar of Societies on 20th October 2004. In October 2024, we will be celebrating 20 years of the existence of the BSSA.

Relatively young as it is the BSSA has achieved much in the 20 years. Within 4 years of existence, the BSSA sent its very first Olympians Sam Paxinos and James Kamyuka to the 2008 Olympics in Beijing, and thereafter to every Olympic Games save to support the athletes to thrive, such as; High Performance Camps at the High-Performance Center in Pretoria, with by world renowned Olympic Coach Rocco; Provisions of Strength and Conditioning Support, Sports Psychologist support; and Physiotherapy support.

A key component for us as the BSSA, is our Coaches. This programme can never be a success if we do not consider that at the center of the Athlete's success is the coach behind the swimmer. There is no point building all this support around the swimmer when we are not working with the coach.

The Coach is pivotal to the Programme, as the implementer. We as the BSSA have therefore had a fruitful workshop at the



for the 2012 games, with swimmers such as Naomi Ruele, David Van Der Colf and James Freeman meeting qualifying times.

Meeting qualifying times is not child's play. The qualifying times met by our swimmers 8 years ago are being swam by our swimmer now, yet the qualifying times keep getting tougher and tougher as the world standard gets higher and higher, and it is becoming increasingly difficult to qualify for international competition, let alone Olympic games.

What this tells us, as a Federation, is that we need a National Plan. We need to work together as a Federation and our coaches and stakeholders to up our standards and elevate our athletes from a young age to reach their full potential and meet the challenges of ever-increasing qualifying times. This challenge starts when the swimmer is young and at the development stage.

NATIONAL PLAN / STRATEGY We were here last year at the end of August 2023 to bid farewell to our Junior Team that was competing at the Junior World Aquatic Championships in Natenya Israel, when DTCB graciously agreed to sponsor our team to the tune of P100 000.

DTCB is very clear in its direction, that their interest is the swimmer. We loved this! This was exactly what we were looking for. A sponsor who knows what they are looking for. A sponsor who knows what sports is and what to look out for. This of cause fell directly in line with our Strategic Objective of IMPROVING ATHLETE PERFORMANCE. To achieve our desired strategic goal of: Qualify swimmers with minimum "B" times at international competitions; Medalling swimmers at continental and international competitions; Qualifying swimmers at the highest level at SA competitions.

This sponsorship from DTCB comes right at the right time, at the start of an Olympic Cycle, to support our swimmers to aim to reach qualifying times for 2028 Olympics. THE SPONSORSHIP

In that way, not only will the swimmers on the programme benefit, but all the swimmers registered under the BSSA, who will have the benefit of working with a coach who, will be working with a coach who, as of next week, we will be seeing 5 of his swimmers swimming at the Olympic Games in Paris, coach Rocco Merrin.

Swimming has always been a sport of discipline, dedication, and determination. It embodies the spirit of hard work and perseverance. Our athletes train tirelessly to push their limits, break records, and inspire the next generation of swimmers. However, achieving excellence requires more than just talent and hard work—it requires support and investment.

DTCP shares our passion for the sport and recognizes the importance of supporting our athletes, coaches, and development program. Their generous contribution will provide essential resources for training, and development initiatives. It will enable us to enhance our competitions, offer better support for our athletes, and ultimately, help us achieve our goal of being a leading force in the world of sport in Botswana.


